APPLICATION PROCEDURE

For full consideration in the Fall and Spring semesters, applications must be received by April 1. For full consideration in the Summer sessions, applications must be received by March 15. In addition, students must be admitted to a graduate program in the College of Business and have all test scores, previous college transcripts, letters of recommendation, resume, and statement of purpose on file at the Office of Graduate Studies and Research.
